REORGANIZATION AND REDESIGNATION OF
CERTAIN OREGON AIR NATIONAL GUARD UNITS

Pursuant to authority contained in Letter, Departments of the Army and Air Force, National Guard Bureau, Subject: Authority to Redesignate and Reorganize Certain Oregon ANG Units, file NG-AFOTP, dated 15 September 1960, the reorganization and redesignation of the following units, Oregon Air National Guard, Portland International Airport, Portland, Oregon, is announced, effective 1 October 1960, with Unit Manning Document and Authorized Strength as indicated. No change in station. Minimum maintenance strength will be in accordance with ANG National Guard Regulations 35-05 except that the 244th Radio Relay Squadron may revert to 12 months Organizational Phase Strength. Missions will be in accordance with Part I of specified UMD. The redesignated units are assigned to the 252nd Communications Group (Mobile) concurrently with redesignation.

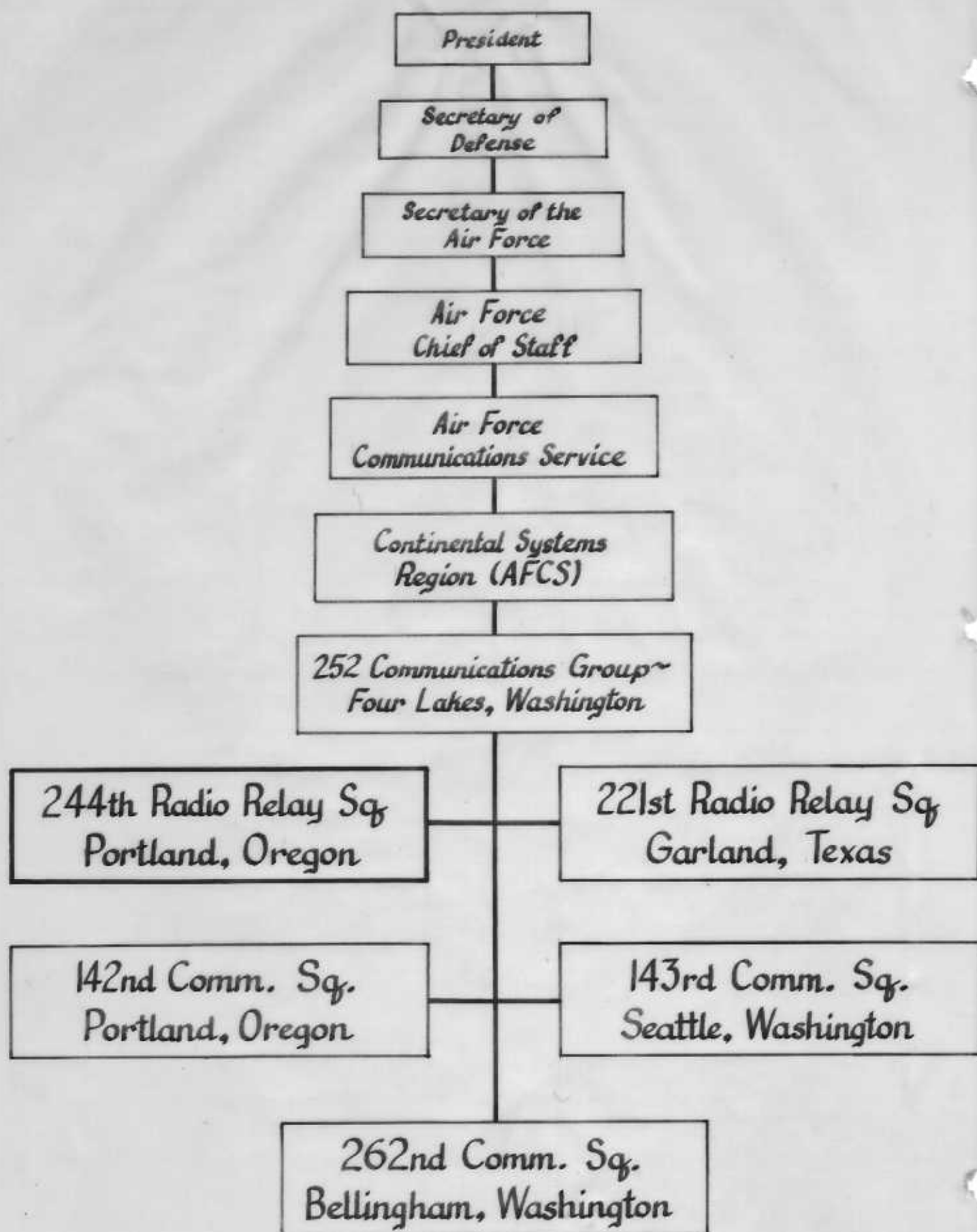


