
## SUMMER CAMP AUGUST 1963

Summer camp beginning 17 August 1963 to 1 September 1963.

- 1. The 244th Radio Relay Squadron took part in exercise Longhaul number two, a communications exercise involving units across the nations.
- 2. The 244th Radio Relay Squadron established and maintained twentyfour hours per day seven radio relay sites and four terminal sites during
  the two weeks. The terminal sites were located at McChord Air Force Base,
  Wash., Portland Intl Aprt, Oregon, Condon AFB, Oregon, Yakima Firing Center,
  Wash. The seven radio relay sites were located at Mt. Crawford, Wash.,
  Mt. Bebe, Wash., TVOR site, Oregon, Mt. Hood, Oregon Shaniko, Ore gon.
  Two radio relay sites were operated by the 221st Radio Relay Squadron to
  complete the circuit. They were located at Blue Light and Yakima Ridge,
  Washington.
- 3. To support the 262 Squadron eight voice and four teletype circuits were dropped out at Portland, Oregon. Also for the 143rd Squadron five voice and four teletype circuits were dropped out at Condon, Oregon.
- 4. Each radio relay site consisted of six to eight men. Five sites were provided with house trailers. The main purpose of the house trailers was to provide a cooking and sleeping area.
- 5. The net control was located at Portland International Airport as well as the headquarters of the squadron. All supplies and spare parts were supplied from Portland.
- 6. A food run was established to send fresh food to sites every other day.






ALL AZIMUTHS ARE MAGNETIC
