I. MISSION AND CAPABILITIES

A. MISSION: The peacetime mission of the 244th Mobile Communications Squadron (Contingency) is to attain and maintain an optimum effective capability to carry out roles and tasks assigned in gaining Command plans for utility in national emergency.

B. CAPABILITIES:

1. Command and management of assigned resources.
2. Installation, operation and maintenance of radio relays and mobile radio relay terminals at unprepared sites. Includes VHF or UHF/FM microwave and tropospheric scatter equipment. Also responsible for the installation, operation and maintenance of radio communications tributary teams and for linking those teams to relay centers by radio communications. Includes telephone, teletype, radio and communications center functions.
3. Organizational and field maintenance of organic communications equipment including ground power equipment and motor vehicles.
4. Administration, security, supply, transportation, food service and medical capabilities to enable optimum self-support in mobile, tactical situation.

1. The 244th AACCS E&I Squadron was organized on 7 Jul 56 under authority contained in General Order 46, The Adjutant General, Oregon, dated 24 May 56 as outlined in UMD 1-2221, dated 1 Jun 55.

2. The unit was redesignated from 244th AACCS E&I Squadron to 244th GEEIA Squadron effective 1 Jan 59 under authority contained in General Order 24, The Adjutant General, Oregon, dated 20 Feb 59.

3. The unit was redesignated and reorganized from 244th GEEIA Squadron to 244th Radio Relay Squadron effective 1 Oct 60 under authority contained in General Order 63, The Adjutant General, Oregon, dated 23 Sep 60.

4. The unit was redesignated and reorganized from the 244th Radio Relay Squadron to the 244th Mobile Communications Squadron (Contingency) under the authority contained in General Order 12, The Adjutant General, Oregon dated 4 Mar 68.

D. Major Philip G. Saxton, FG787059, assumed command upon reorganization 16 March 1968.

C. FIELD TRAINING FOR CALENDAR YEAR 1967.

1. During the period immediately preceding this report the unit devoted considerable time in preparation for participation in Exercise "KITTY HAWK". Shortly prior to departure for the exercise area the Squadron received word that "KITTY HAWK" had been cancelled due to the middle east crises. Because squadron members had already committed the period for field training which differed from the rest of the Communications Group it was decided to go ahead with field training during the originally planned time frame at home station and at Camp Bonneville.

(a) The first period of the field training exercise was spent in conducting contingency exercises using home station as a base of operations.

(b) The second period of training was located at Camp Bonneville.

(c) The entire unit went thru the National Guard Bureau's program for Riot Control and Domestic Disturbance training. Basic Riot Control formations, chemical warfare training and street fighting fundamentals were presented to the personnel. Each "pla-

toon" was sent thru a mock village area where "riots" were being simulated very vividly by "aggressor" type personnel.

(d) Along with the above the unit personnel were given a comprehensive exercise in survival training. One of the squadron officers had recently completed the AFCS survival school. The rugged terrain in and around Camp Bonneville lent itself very nicely to survival problems.

D. CONDUCT OF UNIT TRAINING ASSEMBLIES:

1. Exercise on October 1966 Unit Training assembly week and saw a terminal team at the Warm Springs Indian Reservation with the other end terminating into the relay center at the Hillsboro Armory. Two landline teletype commercial circuits were interfaced into the system at Portland International Airport and carried on over to the relay center.

III. REORGANIZATION

Advance word was received that the unit would be reorganized during this period on or about 16 Mar 68. The impact of this information triggered extensive interviews with personnel who were required to retrain following the advent of the reorganization. Career fields new to the squadron were included within the new Unit Manning Document (UMD). A significant portion of the hard work previously accomplished in the recruiting and training of radio relay repairmen was laid aside. Following receipt of the new UMD personnel were reclassified and the new sections consisting of telephone maintenance, refrigeration, radio communications operations, Communications Center Operations, Technical

Control and Teletype Maintenance were organized and established. Justifications to fill the Air Technician Communications Operations Technician position came into being but it was not to be filled until man years hopefully became available immediately following this period. No new equipment was received to support the communications function however the two terminals and seven relays were shipped to our sister squadron in Washington, the 262nd Mobile Communications Squadron at Bellingham.

The squadron said farewell to its one and only commander, L/Col Albert E. Garvin, since its original organization in 1956. L/Col Garvin assumed command of the 142nd Mobile Communications Squadron on 16 March 1968.

IV. MISCELLANEOUS

A. SSgt James E. Stewart was named the Unit Outstanding Airman for CY 1967.

B. A marksmanship team composed of SMSgt Ray Dragowsky, Ralph Mesick, TSgt Arthur Willard, SSgt Richard DeMars, and Sgt Jan Anderson won the Oregon National Guard .22 Cal. Rifle League championship.

C. Social Functions. On 19 April 1968 the WCO's of this unit held their 4th Annual Dining-In with the officers as guests. Invited guest present were the State Adjutant General, Maj General Donald N. Anderson; the Assistant Adjutant General for Air, Brigadier General Staryl C. Austin Jr; Chief of Staff for Air, Brigadier General Gordon L. Doolittle; Commander
