DESCRIPTION: On a light blue disc edged yellow a sphere with axis palewise, the dexter half yellow grid lined black, the sinister half black grid lined yellow, overall in bend a red lightning flash. Attached above the disc a blank white scroll edged yellow. Attached below the disc a white scroll edged yellow and inscribed "Dic Quando Et Ubi" in black letters.

- The globe, half in daylight, the other half in darkness, symbolizes time.
- b. The globe on the blue background is symbolic of aerospace communications.
- The red lightning links the day and the night and extends the dimensions of the world and beyond.
- d. The Latin inscription, "Dice quando et ubi", is literally translated, "Say when and where."
- 4. The 244th Mobile Communications Squadron (Contingency) was granted federal recognition in its present configuration on 16 Mar 1968. This unit was first organized on 7 Jul 1956 as the 244th AACS E&I Squadron. Later on the unit was redesignated and reorganized from the 244th GEEIA Squadron to the 244th Radio Relay Squadron effective 1 Oct 1960. Air Force Communication Service is the units gaining command. The unit has seen no federal service.
