COMMENTS: Our participation in JCS exercises over the past few years has caused us some heartburn and many problems as we became educated in the ways of the USAF. It is my belief, however, that we have received some of the finest training for our people that could be provided in preparing for our active duty mission.

The ultimate compliment in this program is recognition by the Air Force of the professional accomplishments of our airmen. I am quoting verbatim a letter we received from the Air Force in Alaska which illustrates my point. I am extremely proud of the outstanding job accomplished by our people in this exercise. You can be justly proud of yourselves.

1. It is with great pleasure that I extend my sincere appreciation to you and the personnel of the entire 252nd Combat Communications Group for their totally superior support of the Joint Readiness Exercise JACK FROST 77.

2. When the JACK FROST 77 Planning Conference opened at Fort Lewis, Washington, 27-29 Jul 76, it looked like the high cost associated with providing active duty communications augmentation would likely force a cancellation of the exercise or severely limit the available comm support. Your decision, made during the conference, to provide 252nd support was critical to our overcoming this serious budgetary constraint. Your participation enabled us to reduce our required airlift cost alone by approximately half a million dollars.

3. My planning staff relied heavily upon the demonstrated excellence and experience your personnel have obtained during prior JACK FROST exercises. Members of the 252nd were instrumental in successfully integrating all facets of the communications deployment effort into one cohesive support system. The 252 comm equipment was vital in the establishment of the extensive tactical communications system which provided rapid, dependable communications under the demanding circumstances of the Alaskan environment. The performance of the operators and maintainers supporting the exercise throughout Alaska was of the highest professional caliber.

4. The personal involvement of the officers and men of your organization in the task of integrating Army and Air Force components, including active and Air National Guard elements, has helped to advance and support the total force concept on which our national defense is based. I can say without qualification that had it not been for the deep involvement of the 252nd in this exercise, the Joint Task Force Alaska would not have had the required quantity and quality of communications available for JACK FROST 77.
