

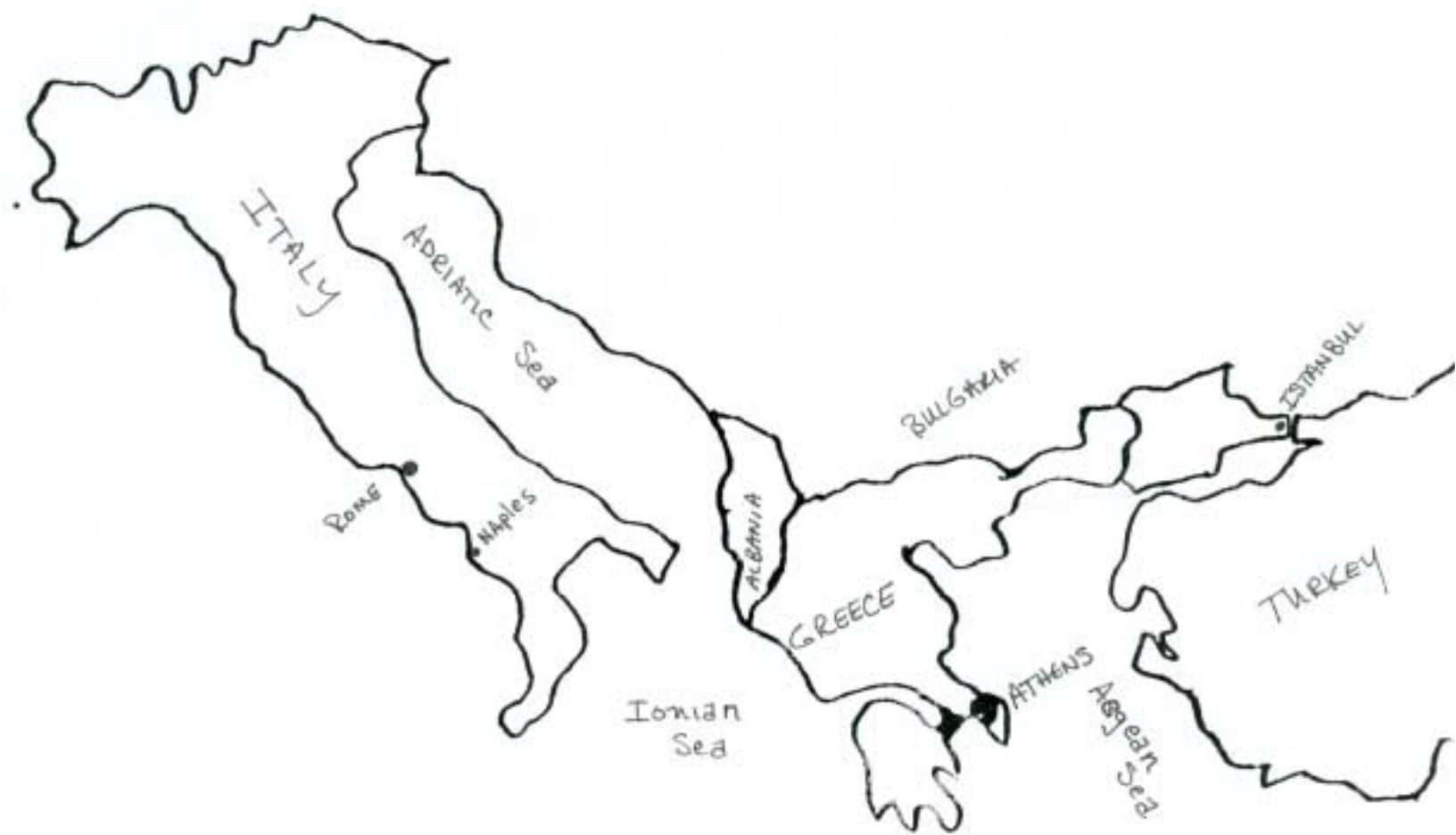

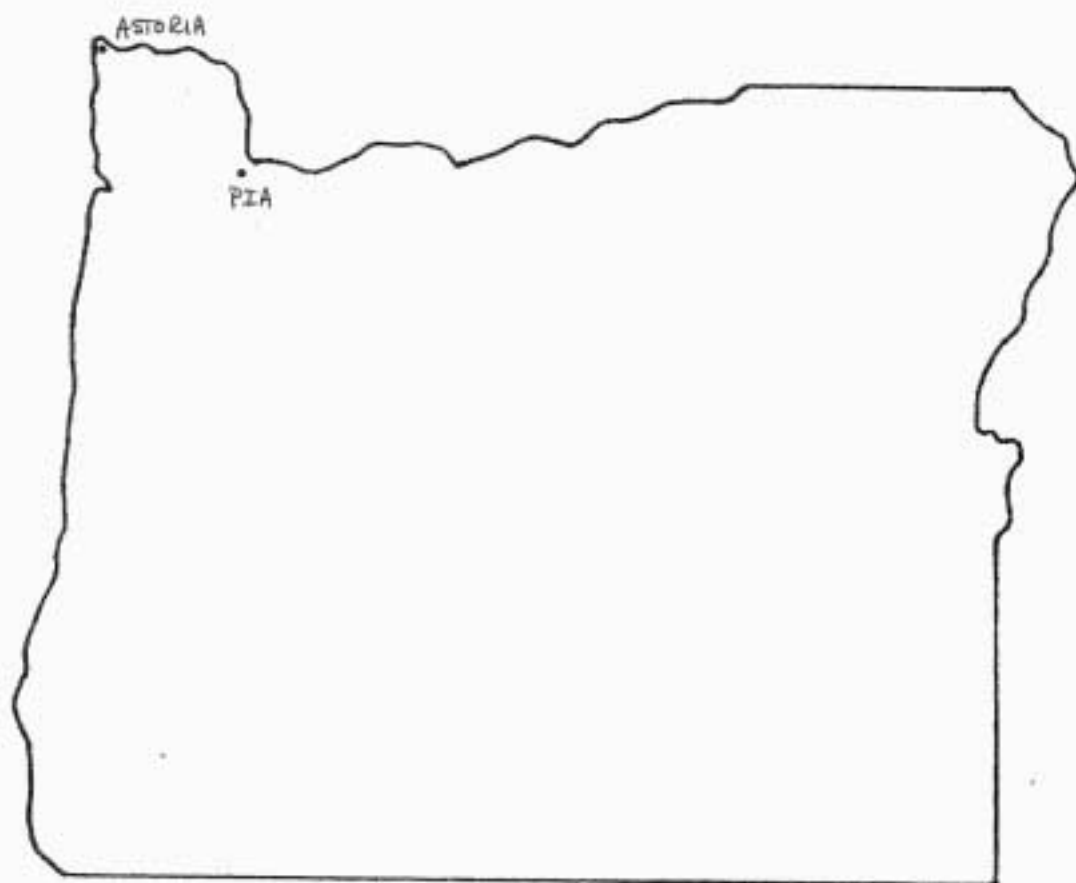

This is an expression of my appreciation for the outstanding support provided by the 252nd Mobile Communications Group during our Felix Libel exercise on 2-3 October 1982. Felix Libel was a very important exercise for us, because for the first time, we deployed and tested a 25NORAD Region command element and associated radar control teams.

During the live fly portion of the scenario, the only communications available for command and control were High Frequency (HF) and Ultra High Frequency (UHF) radio assets from the 252nd. Their teams and equipment were deployed to five locations, where they installed and operated a multi point HF net for battle management plus a UHF net for control of air defense aircraft. The readability and reliability of the nets were excellent - all traffic was passed quickly and all operations were fully supported.

Again, my thanks for your support. Please pass to your people that I salute their professionalism and can-do attitude. I think this exercise was an excellent first step for us, and I am looking forward to future participation between our units.

2. All of your personnel are to be commended for their professional effort. Once again you have proved the Air National Guard is a vital part of the Total Force.



## ANG gives 'Gallant Eagle' aide

PORTLAND AIR BASE — Tents shredding, port-a-potties blowing over, and drifting snow and sand; this was the environment for 104 members of Oregon Air National Guard's 244th Combat Communications Squadron and Flight participating in Joint Chiefs of Staff Exercise "Gallant Eagle 82."

Scenic California locations such as Logans Mine and Rodman Mountain in the Mojave desert were home for the Air Guard units from March 21 through April 7.

The purpose of the exercise was to simulate a combat environment to Rapid Deployment Joint Task Force. The JTF and its assigned multi-service forces exercised tactical employment operations in a desert environment. Members of the 244th provided communications for the JTF Air Forces commander and

Marine Forces commander.

Airmen from the 244th at "Rodman Relay" were sitting on top of a 6,000 foot windswept mountain southeast of Barstow, Calif. The high winds reached over 125 knots on one occasion — making life miserable on the site. In spite of the high winds and occasional snow, the Air Guard members drew compliments on their highly professional performance from the exercise commander.

The terminal team which provided communications for the opposing force Marine headquarters also operated in tough field conditions. They had a daily menu of "C" rations, slept in small tents in the desert, and camouflaged their entire site. They also set up the system in a manner beyond normal expectations, according to the Marine commander. "This is the first time Marine headquarters had such high quality communications support," he said.




