Colonel Gene A. Katke receives his Star, with an effective date of 15 May. Brigadier General Katke was one of the original members of the 244th and served as Commander of the 244th from 1 June 1977 to 1 October 1983.

On 28 May, Governor Barbara Roberts announced that Brigadier General Katke would succeed Major General Rees as Oregon's Adjutant General, effective 1 July 1991.

Brigadier General Katke is the first Air National Guard officer appointed to the position of Adjutant General for the State of Oregon. On 31 July, Brigadier General Katke announced the appointment of Colonel Keith E. Hallmark as the new Assistant Adjutant General for Air. Colonel Hallmark was Commander of the 244th from 1 October 1983 to 1 June 1990.

January 1991

5-6 January -- Modified 36-Hour

This UTA was a 36-hour (modified) exercise designed to provide maximum allowable time for realistic operations training. Maximum use of the lease land line to the 143 CCSQ for the 244 CCSQ was planned. Primary emphasis was on training operations personnel.

February 1991

2-3 February -- 8-Hour Operation

The UTA was designated an 8-hour operation. The leased land line to the 256 CCSQ was terminated in the TGC-27 van Saturday and Sunday. The mini CFP participated in a CPX Saturday and Sunday. A DCS entry was conducted between the 244th and Norfolk, Virginia. The UTA was utilized to provide operations and classroom training.

Three DP instructors were sent to Gresham to help the Army Guard with their DP program.

A Spouse Awareness class was held on Sunday afternoon for all spouses of the 244th CCSO.

March 1991

2-3 March -- No Host MOBEX

The UTA was designated as a No Host MOBEX training period in preparation for the April 36-hour deployment. Our mission was to successfully prepare the designated UTC's for ground deployment using mobility training concepts and procedures.

April 1991

6-7 April -- 36-Hour Deployment

During this UTA the 244th participated in a 252 CCGP 36-hour employment exercise. The primary purpose of this deployment was to practice deployment and employment capabilities, and gain momentum toward our upcoming ORI. The primary mission of this deployment was to allow maintenance and operations personnel the opportunity to practice, in a deployed environment, those skills developed during in-garrison training since the last deployment.

Deployment was made to Clark County Fair Grounds, Washington, with the exception of three TRC-97's which were positioned at Livingston Mountain.

18-19 May -- Commander's Option

The UTA was designated a Commander's option. The UTA was utilized to provide operations and classroom training. An open ranks inspection was held during this UTA.

June 1991

15-16 June -- Commanders Option
