***January-1993***

UTA'S\*\*\*

9-10 January -- Modified 36 Hour

This UTA was designated a 36 hour (modified) exercise. This exercise was designed to provide maximum allowable time for realistic operations training. Maximum primary emphasis was on training operations personnel.

### ***April-1993***

3-4 April -- Modified 36 Hour

This UTA was designated as a 36-Hour (modified) exercise. The UTA was designed to provide maximum allowable time for realistic operations training. Maximum use of the on base land line to the 272 CCSQ for the 244 CCSQ was planned. The TSC-93 was used to communicate with the 272nd CCSQ TSC-93 over satellite. The TSC-60 made a DCS entry to DCS station Stockton. The 244CCSQ TRC-170's operated point-to point from the 244 CCSQ to the 272 CCSQ. The URC-119 participate in packet operation with other 252 CCGP units. The wideband and satcom systems used as alt-routes for base cable circuits. The mini-CFP was operational during the UTA. The SB-3865 switchboard operators and maintenance personnel deployed to Camp Rilea for training.

### ***May-1993***

1-2 May -- Commanders Option

This UTA was designated as a commanders Option UTA. Training activities included Air Troop Command Training CWDI initial and refresher Training OPSEC and Protection of the President Training.

### ***June-1993***

5-6 June -- Commanders Option

The UTA was designated as a Commander's Option UTA. Training activities included: ETAP Training (Wideband, Ground Radio and Job Control), Team Chief Pallet Buildup Training, New Comer's Orientation, OJT Managers Meeting, Classified Courier Training. Also a job Control/Maintenance Control Activity Inspection was planned.

In support of exercise Patriot Falcon'93 accomplished by affected workcenters. Hours of duty each day were 0730 to 1600.

### ***July-1993***

17-18 July -- Commander's Option

This UTA some sections were continuing the preparations begun on 16 July to reconfigure equipment from Patriot Falcon'93 for deployment during the September 36 hr. exercise. There was no August UTA planned. Inspections were planned by the Wire Maintenance, Maintenance Control, Ground Radio, and Communications Operations sections. The annual Physical Fitness Test were conducted. The UTA was be utilized to provide AFSC and mobility training, begin preparations for the September 36 hr exercise, perform annual Physical Fitness Testing, and conduct our annual Family Day/Picnic.

### ***August -1993***

There was no UTA in August!

### ***September-1993***

11-12 September--Deployed 36-hour

The UTA was designated as a Deployed 36 hour exercise for the 244 CCSQ. The primary purpose of this mission was to allow maintenance and operations personnel the opportunity to practice in a deployed environment, those skills developed during in-garrison training, and to familiarize themselves with the operations practices with their respective distant ends.

### ***October 1993***

16-17 October --Commander's Option

This UTA was utilized to provide section and classroom training on Saturday and Sunday. All sections conducted OJT and qualification training. An ACC Assessment Guide overview briefing for all supervisors and unit key personnel were given. All newly assigned personnel received TQM orientation.

**November - 1993**

13-14 November--Commander's Option

This UTA was utilized to provide section and classroom training. On 6-7 November EC, Engineer, Radio Ops, COMSEC and DW members of this unit will be attending a two day conference at Camp Murray, WA.

**December-1993**

4-5 December--Commander's Option

This UTA was utilized to provide operations and classroom training.
